**Code of behaviour**

1. The participant is required to actively participate in activities organised by supervisors, follow the rules set out by the camp and the centre.
2. The organiser is not responsible for any stolen goods, which have not been deposited to the supervisor.
3. The participant is required to have an appropriate identification with them- passport.
4. **During the camp, there is a strict rule regarding no alcohol, smoking, drugs or any other stimulants. Additionally, electronic cigarettes and bongs are strictly prohibited.**
5. The participant is required to follow rules, which are present in the centre as well places visited (this includes fire drills, moving around in public, curfew and using swimming pools).
6. **Participants cannot leave the centre without prior agreement with the supervisor.** They also need to act well accordingly to the culture and principles of the country they are in.
7. **In a case of a participant being caught smoking, drinking alcohol or other stimulants, they will be removed from the camp immediately on parent's own expense. The parent/guardian must pick up the child within 48hours.**
8. Parents/guardians are responsible for goods being destroyed by the child.
9. Resignation from the event after it has started (from the participants fault or parents will) or not attending all activities means no costs will be returned.
